Program Description: Home Share Now helps cultivate home shares in central Vermont between home providers and home seekers, creating mutually beneficial relationships to expand the possibilities of living.

Home providers offer a bedroom and access to their home's common area, while the home seeker provides assistance—be it chores, transportation or just companionship—in exchange for reduced or waived rent. Our home seekers' average rent last year was \$290/month, while 31% paid \$0 and instead provided up to ten hours/week of service.

For example, meet Lois and Mary. As a single lady in her 60s facing some new physical challenges, Lois realized that she couldn't stay in her home without some help. Then she found Home Share Now. Our staff met Lois in her home, learned as much as we could in an hour and a half, and made a list of the tasks she was looking for help with.

One of the things we learned is that Lois is quite the knitter!

Mary, on the other hand, came to Home Share Now as a way to find affordable housing in close proximity to a new job. Mary, an experienced home sharer, also has a love of fiber; for example, repurposing old wool sweaters into hats. Crafty! Mary was interested in offering housekeeping, cooking, and gardening in exchange for her housing.

After both Lois and Mary were thoroughly vetted the two were introduced by a Home Share Now staff. Lois found Mary's contributions—from painting, lifting and organizing—incredibly advantageous. She also appreciated the presence of Mary's cat Emmy. When asked about the program, Lois had this to say: "With Home Share Now I feel secure that I will be able to stay in the home."

Home Share Now is the only organization of its kind in central Vermont. It helps all kinds of Vermonters—from people with low incomes and disabilities to the elderly—address their financial, physical and emotional needs by helping each other.

Our home providers have an average age of 78, and for home seekers, 56. Of all our participants, 78% are female, and 85% fall within low income limits.

Older adults form the largest share of our beneficiaries for many reasons. Financially, they tend to have lower incomes, often relying on Social Security alone. Physically, they tend to be the most affected by health problems, reducing their mobility. Socially, they tend to be more alone, due to restricted social networks, declining driving ability or vehicle access, and our isolating New England geography.

There are also simply more aging adults. Vermont is the second oldest state in terms of median age, and is only getting older with the "graying of America" fully underway.

Equally pressing for all ages, however, is the state of our housing market. Being simultaneously the second least populous state and third to fourth lowest in terms of rental vacancies, Vermont puts low-income residents in a very tough spot. In fact, Vermont exceeds the national average for cost-burdened and severe cost-burdened households for both renters and owners. Renters are certainly the worst off, however. The majority of available multifamily rental units in the state are provided by the government, but these are also the most in-demand, having around a 0.7% vacancy rate compared to the 4–6% deemed healthy for all units nationwide.

To make good matches, our process includes background checks and references for all participants, in-person interviews, employment verification when applicable, facilitated introductions, a two-week trial period, and written agreements.

We are the only home sharing program in the United States with a staff mediator, who helps participants draft the personalized agreement covering the small but crucial details—not usually included in a lease—that tend cause the most disagreements: cleanliness, sharing the kitchen, use of common spaces, shared expectations, etc. The mediator provides on-going support for the life of the match. Our only participant fee is a sliding match fee based on income, which comprises about 4% of our total income.

While home sharing is our primary focus, we also offer two additional services. Giving is from the Heart (GIFT♥) is a community volunteer program where enrolled home providers are able to receive services over and above those offered by their live-in matches. After undergoing a vetting process similar to that of our other participants, volunteers are dispatched either on a one-time or repeating basis.

Our third program provides one-on-one conflict coaching, small-group mediation, facilitated community meetings, and staff trainings to our housing partners managing low income and/or senior housing properties. All three of Home Share Now's programs work to stabilize housing for vulnerable populations.

What services does your organization provide that are not available elsewhere? Home Share Now is the only home sharing organization in central Vermont, and the only entity providing housing mediation outside of the legal system.

What (if any) organizations provide similar services? There are no organizations providing similar services in central Vermont.

If applicable, how does your organization collaborate with organizations providing similar services? Our collaboration with other organizations includes cross-referral for participants, collaborative strategizing about Vermont's affordable housing crisis, and participant outreach. We also share resources with HomeShare Vermont, our sister organization, and together keep the legislature updated as to our activities.

In what way are the services your organization provides preventative in nature? Our services are preventative in nature in the following ways:

- Used existing, underutilized houses to combat our affordable housing crisis
- Stabilize housing for vulnerable populations, preventing homelessness
- Saved home providers on fixed incomes the expenses related to paid services
- Prevented home seekers on limited budgets from paying unaffordable rents
- Prevented caregiver burnout by adult children
- Delayed or prevented the transition to assisted living facilities by older adults
- Saved energy and resources through communal consumption
