- > Introduction to tonight's meeting
- > Importance of Town Plan: considered during Act 250 hearings, important if town is seeking grant funding

Overview of Two Meetings on draft Plan

Topics to be discussed at tonight's meeting:

- ➤ Land Use
- Natural Resources
- ➤ Comment period ends 10/20/12

Natural Resources

Water Supplies

- Letter dated 10/2/12 from Paul Erlbaum received by the PC
- ➤ Would like strong language in the Town Plan; don't water down the intent
- ➤ Goals are too general; be more specific
- ➤ Goal #2 add monitoring; include IP's in discussions regarding water
- Action #7 don't use state limit; use a specific 35,000 gallon limit
- When property with water rights changes hands, be sure town can review the permit again
- > Continue to be an example for other towns; support for letter to PC
- > Don't take our water for granted; seems like we have a lot now; other places have been destroyed by extraction
- Climate change is unpredictable; look to the future
- ➤ Talk with Senator Ginny Lyons about NAFTA issues
- > Goal proactively preserve and protect groundwater resources; stay on top of methods to naturally manage storm water
- Make strong goals and make actions take advantage of new technologies; stay on top of the issues
- > Push for stronger protection of our water; preserve water for non-commercial use
- > Use the same forward-thinking approach from the Energy chapter in the Water chapter

<u>Scenic</u>

- > Use the wording: the 6-acre swimming hold known as Coburn Pond, not former gravel pit; change in other places in the Plan
- Appreciation of mention of North Montpelier; East Montpelier = East Montpelier Village, North Montpelier = North Montpelier Village

Wetlands / Waterways / Wildlife

- No talk of protecting ponds, Winooski River and Kingsbury Branch, including buffer zones (like Calais)
- > Consider specific water protection zoning regulations
- > Action explore methods to control storm run-off with new and innovative methods

Earth Resources

- Add geological and groundwater mapping to the chapter
- > Add Geology to the title; expand chapter regarding descriptions of the geology in the town; reference the map

Forest Resources

- ➤ Invasive species keeping track of potential dangers
- Discussion of insects/pests & diseases affecting the forests

Land Use

Wastewater Disposal

- Another place to mention surface water protection; protect the riparian zone; maybe belongs in Wetlands chapter
- ➤ Goal #2 include North Montpelier Village for wastewater solution
- No mention of 2005 ordinance; Sewage Officer still enforces under that ordinance; find actual title of ordinance
- Town still enforces its old permits
- Final draft will include total permit figures

Agriculture

- Some seeds made by Monsanto have their own pesticides in them
- > Genetically modified seeds (GMO) affect the land around them; alert the townspeople re: where they are planted
- Legislature was not able to ban these seeds; someone should research an EM moratorium from 5-6 years ago on planting GMO seeds; what can town legally do?
- > Townspeople have concerns add paragraph about protecting our organic farms and discussion about GMO issues as they affect the town
- > State statutes limits town restrictions on agriculture
- Protect agriculture land from development
- Add to crops in town: herbs and flowers, berries

Villages & Growth Areas

- ➤ Add Post Office in North Montpelier as business in town
- Add goal of exploring water and wastewater in North Montpelier Village
- > Add goal North Montpelier Village signs; historic marker for village and singing bridge being installed this year

Housing

- ➤ EMSLI paragraph change units from 15 to 21, based on 2007 market analysis
- ► Goal coordinate building needs in the town; mentioned anywhere in the Plan?
- Town building needs to be reviewed
- Capital Planning & Budgeting to be done by PC; possible mention in Finance chapter
- ➤ Goal #3 include "and low-income residents"

Land Use Patterns & Zoning

- Change to North Montpelier Village
- Conservation overlay include language regarding Coburn Pond; consider changing zone so as to protect the area of the pond; constructed wetland needs to be protected; needs clarification of conservation zone
- Wildlife corridors versus development; think about that re: where development happens; blocks of unfragmented land
- Last goal needs stronger language regarding strip development
- Include discussion on riparian buffer zones here, as well

Comments

- Regulations make certain references to permit reviews for groundwater permits changing hands
- ➤ Be consistent East Montpelier Village and North Montpelier Village
- > Specific zoning regulations for run-off
- ➤ Map section add Geological Survey Bedrock maps for Earth Resources
- > Discussion regarding coordinating various needs (Town, schools, FD) & capital planning and budgeting; include as a goal?
- What are we going to do about space for Town Clerk's records; facilities or capital budget issue?
- Wildlife corridors relative to development (not mapped); Plan does discuss unfragmented forest land

Wrap-up

Deadline for additional comments is October 20th. Next steps: PC will review all comments and revise chapters; assemble a draft with maps and figures; hold public hearing in Jan 2013 and make an necessary revision; submit plan to SB in Feb 2013 and if approved by SB, send to the CVRPC.
