East Montpelier Selectboard Meeting APPROVED (04/07/14) MINUTES March 17, 2014 at the Municipal Office

Selectboard members present: Carl Etnier (minute taker), Seth Gardner, Casey Northrup, Kim Swasey.

Others present: Bruce Johnson (town administrator), Don Welch (town treasurer), Vermont State Police Lt. Matt Nally, VSP Captain Paul White.

A. CALL TO ORDER

Chair Seth Gardner called the meeting to order at 6:38 pm.

B. ADDITIONS TO THE AGENDA

None

C. PUBLIC COMMENT

None.

D. DISCUSSION WITH VERMONT STATE POLICE; CONSIDERATION OF 2014 STATE POLICE CONTRACT

Captain Paul White introduced his successor in charge of the Middlesex Barracks of Vermont State Police, Lt. Matt Nally. Mr. Nally said that he is interested in helping to clear up open cases and get more eyes helping them. He also emphasized the importance of reporting thefts, even small ones--what they don't know about, they can't investigate or put together into a pattern.

Mr. Etnier asked whether VSP has a policy on communicating the resolution of a reported crime or incident.

Mr. Nally said VSP cannot divulge information about an ongoing investigation. The person reporting is entitled to information once an arrest is made.

Mr. White added that VSP likes to be able to report to a victim when an arrest is made. It's unusual to recover stolen property and make an arrest.

Mr. Etnier said he reported two incidents last year of a motorist driving too close to him while he bicycled, and he would like to have heard back from VSP regarding the resolution or lack thereof. It makes a citizen more interested in reporting to police if they know the report is getting attention.

Discussion of hot spots. Mr. White and Mr. Nally could not identify current crime hot spots in EM. Mr. White said that VSP will respond to what you tell us about. Mr. Nally said that those who are doing the break-ins are using the roads, so it's helpful to be able to stop cars and get a look into their vehicle.

Mr. White added that Crimereports.com shows where crimes of a specified type have been reported. It may not be updated since reporting codes changed at beginning of year.

On the town's contract with VSP: Mr. White reported that a bill in the legislature would prohibit VSP from entering this sort of contract. It has passed the House and is in the Senate. If it becomes law, East Montpelier would have the option of the County Sheriff or a municipal police department for this sort of contract. He doesn't know of the motivation behind the bill.

Mr. White added that the Central Vermont Public Safety Authority may in the future be something that the town could join.

Questioned about the high turnover rates at the Middlesex barracks that Mr. White had previously reported to the Selectboard, Mr. White responded that in his new position overseeing three barracks, he has moved a position from Chittenden County to Middlesex, but Middlesex could use another five.

The VSP contract offer for 40 hours monthly is \$30, 264, increased by 10% over last year. Mr. White and Mr. Nally said the number is based on a statewide average for overtime, without giving details about which factors have had the most effect on the rate jump. East Montpelier consistently pays less than the contract amount, as the officers assigned to the town are less experienced than average and have correspondingly lower pay rates.

Motion: I move to renew the contract with Vermont State Police for the coming year. Made: Mr. Northrup. Second: Ms. Swasey. 4-0.

E. TOWN TREASURER REPORT

Mr. Welch distributed a report on the current state of spending. The town is in good shape with respect to the budget. Spending on gravel is a bit high. We have a little extra to use in paving. On taxes: The town billed about \$590,000 more last year than the prior year. So far the town has about \$220,000 more in taxes remaining to be paid than last year. Delinquent taxes are about the same as this point last year. He intends to send out a card this spring reminding people of the May 15 deadline for the second installment of taxes, in addition to notices on Front Porch Forum.

F. CONSIDERATION OF CD OPTIONS FOR CAPITAL RESERVE FUND

There's currently about \$110,000 in the savings account, and \$136,000 in the capital reserve account CD. How much do we want to keep liquid? The difference between a 6-month and 12-month renewal is 0.3% v. 0.4%.

If the town both buys a new truck to replace the LoPro and need extra funds for paving, the \$110,000 will not be sufficient.

Motion: I move to authorize the town treasurer to renew the certificate of deposit for the capital reserve fund for six months. Made: Ms. Swasey. Second: Mr. Northrup. 4-0.

G. CONSIDERATION OF CD OPTIONS FOR FOREST FUND

No one has heard about any planned expenses to be taken from the forest fund.

Motion: I move to authorize the town treasurer to renew the certificate of deposit for the capital reserve fund for 366 days. Made: Ms. Swasey. Second: Mr. Northrup. 4-0

H. CONSIDERATION OF FINANCIAL AUDIT RFP SUBMISSIONS

Four proposals from local firms were received in response to the town's request for proposals for financial audits. Mr. Welch and Mr. Johnson will speak with representatives of the firms and report back to the SB with a recommendation, ideally by April 7.

I. DISCUSSION ON REPLACEMENT OF INTERNATIONAL LO PRO TRUCK

Mr. Northrup reported his research showed that the current Lo Pro has a motor with a spotty track record. The truck's low mileage (less than 70,000) is not an advantage, and it might even be a disadvantage.

Other towns and cities have reported using trucks for 10 or 15 years or more. We want our trucks to get

at least 10 years of use from now on.

Nonetheless, the SB accepts the arguments that the current Lo Pro has uncertain prospects for future years and notes the road foreman's strong interest in replacing it.

The bid from Clark's Truck Center does not include insta-chains, which are important for this vehicle. They cost an additional \$2,100, according to what Clark's has told the town.

Motion: I move to authorize the purchase of an International 7400 SFA 4x2 truck from Clark's Truck Center per their offer of February 10, 2014, for a net sales price (including trade-in) of \$52,461 plus the cost of insta-chains. Made: Mr. Etnier. Second: Ms. Swasey. 4-0.

Motion: I move to authorize the purchase of the Everest dump body and one-way plow and wing plow per the HP Fairfield quote #134916, for \$43,935. Made: Mr. Etnier. Second: Ms. Swasey. 4-0.

J. CONSIDERATION OF RB TECHNOLOGIES CONTRACT FOR IT SERVICES

The current contract with rbTechnologies expires on April 30. rbTechnologies has presented an offer for a one-year contract that lowers the monthly cost by using an offsite system to monitor and maintain the town's servers. The SB asked Bruce Johnson to ask rb to remove the monthly pre-paid hour of work; we'll pay as we go.

K. CONSIDERATION OF PLANNING COMMISSION VACANCY CANDIDATES

Four candidates asked to be appointed to the one vacant position. The SB will ask the planning commission for a recommendation.

L. DISCUSSION ON REMAINING FARM CONTRACTS

Mr. Johnson reported that there are five contracts active after March 31. The remaining contracts will expire over the following two years.

M. 2014 TOWN MEETING REVIEW

Charter committee: The Selectboard would like to keep the committee constituted and on hold, with no immediate agenda. Mr. Etnier will ask chair Edie Miller to poll the committee about who is interested in continuing.

Conflict of interest ordinance: Bruce and Carl will work on improving the language.

N. 2014 SELECTBOARD ORGANIZATION

Motion: I move to elect Seth Gardner as chair. Made: Mr. Northrup. Second: Ms. Swasey. 3-0, with Mr. Gardner recusing himself.

Motion: I move to elect Casey Northrup as vice-chair. Made: Ms. Swasey. Second: Mr. Etnier. 3-0, with Mr. Northrup recusing himself.

Motion: I move to authorize Seth Gardner as primary signer of payroll and vendor warrants and Casey Northrup as secondary signer. Made: Ms. Swasey. Second: Mr. Etnier. 4-0.
