Project Details (alternate versions for 1 1/4" and 2 1/4" depth of top course):

- 1. Gallison Road. 22' x 0.7 miles (3,960'; from the intersection with Towne Hill Road to the paving joint at the City of Montpelier line just beyond the U-32 High School entrance). Pave area with 2 ¼" total average depth of mix consisting of a 1' average depth "shim course" and a 1 ¼" average depth "top or wearing course." Approximately 9,680 square yards; 1,225 tons.
 - Work to also include the placing of shoulders on each side of the road at 2' width where possible. Approximately 140 tons.
- 2. Gallison Road. 22' x 0.7 miles (3,960'; from the intersection with Towne Hill Road to the paving joint at the City of Montpelier line just beyond the U-32 High School entrance). Pave area with 3 ¼" total average depth of mix consisting of a 1' average depth "shim course" and a 2 ¼" average depth "top or wearing course." Approximately 9,680 square yards; 1,770 tons.

Work to also include the placing of shoulders on each side of the road at 2' width where possible. Approximately 140 tons.
