Consideration of Contractor Bids for Gallison Hill Road and Quaker & Vincent Flats Roads Paving Projects and Dodge Road Culvert Repair Project

- We have approximately \$294,000 available for paving this year; we also have \$19,500 budgeted for structures grant projects
- If so desired, we need motions to accept bids for all 3 projects and authorize CBJ to finalize agreements; we gave a short timeline for the projects, so I'll get the message out tomorrow if decisions are made
- Gallison Hill Road Paving
 - See paving bid sheet; this project has a state paving grant (\$110,550; 80/20); we received bids for both shim & 1¹/₄" and shim & 2¹/₄" versions
 - O Best price for 1¼" is below grant level; if we accept 2¼" bid, we could ask VTrans for a grant \$\$ increase; we've tried this previously without success
- Quaker & Vincent Flats Roads Paving
 - o See paving bid sheet; this project will be fully town funded
- Dodge Road Culvert Repair
 - O See structures bid sheet; this project has a state structures grant (\$63,263.25; 90/10); both bids are above grant level; once again, we could request a grant \$\$ increase from VTrans; overage could be covered within the budgeted structures grant projects line

Warrant to Impound Unlicensed Dogs

- Unlicensed, but formerly licensed dogs category is very low this year; unfortunately, this has little to do with the total number of unregistered dogs

 do another site visit so that he (Art) could explain the historic pathway Pat agreed to this; no
 timing for the meeting as yet
 - o Art still concerned about upper (Woodward side) culvert he wants it removed

 - O Quite a few towns do post it
- Open Meeting Law mailing from state legislature
