By the authority of the State of Vermont, you are hereby commanded to levy and collect of the several persons named in the foregoing list herewith committed to you the sum of money annexed to the name of each person respectively, with your own fees, and pay the same to the Treasurer of the Town of East Montpelier on or before sixty days from the date hereof; and if any person neglects or refuses to pay such sums with your fees, you are hereby commanded either to extend this warrant for the collection of such sum so assessed against such delinquent person, with costs, upon any land in this state belonging to such delinquent, according to law, or to take the body of such delinquent person, and him commit to the keeper of the jail, in the county of Washington, (or such other jail as the law directs) within such jail, who is hereby commanded to receive such person, and safely keep him until he pays such sum so assessed with legal costs, together with your own fees, or is released according to law.
