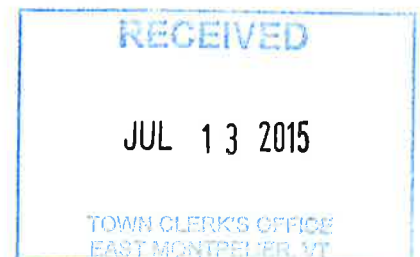
Also included is a summary of the 2014-2015 contract in regards to hours used (479.75 out of 480). I included a recap of tickets, warnings and calls for service as well.
