Dear Ms. Whitney:

The Applicant hereby responds to the Town of East Montpelier's comment letter filed on March 17, 2016.

1. As stated in BDE East Montpelier Lazar Solar, LLC's letter dated March 9th in question response 2 (a), the Applicant has committed to having a landscape professional certify that the plants have been installed in accordance with Exhibit BDE-AT-7 Sheet L-1 (Landscape Mitigation Plan). The Town of East Montpelier has now requested that the Applicant send a copy of that certification report to all parties. The Town has cited no rule requiring a certification to be sent to all parties, but in order to avoid a hearing under the aesthetic criterion, the Applicant has no objection to this request if the Board believes that such condition is necessary to satisfy the aesthetic criterion.
2. As stated in BDE East Montpelier Lazar Solar, LLC's letter dated March 9th in question response 2 (b), the Applicant has committed that after three years from installing the plantings having a landscape professional certify that the plants are in good health and condition. The Town of East Montpelier has now requested that the Applicant send a copy of that certification report to all parties and that the report document any corrective actions necessary if the plants are not in good health. The Town has cited no rule requiring the certification report to be sent to all parties or that such report must document any corrective actions necessary if the plants are not in good health, but in order to avoid a hearing under the aesthetic criterion, the Applicant has no objection to this request if the Board believes that such condition is necessary to satisfy the aesthetic criterion.

The Applicant, however, cannot agree to the Town's request that the same landscape professional be used for both certifications since there is no way the Applicant can control whether that individual is able, willing, or available to perform the work three years later.

3. As stated in BDE East Montpelier Lazar Solar, LLC's letter dated March 9th in question response 2 (c), the Applicant has committed to maintaining the plantings for the Project's life and replacing dead plants within 3 months. The Town of East Montpelier has now requested that the Applicant replace dead or dying plant material found in annual inspections within 30 days. The Applicant cannot agree to this request because if a plant dies in the winter, planting conditions will not allow for replacing such plant within 30 days. The Town has cited no rule requiring a 30-day replanting deadline. In order to avoid a hearing under the aesthetic criterion, the Applicant has no objection to replacing dead plants within two months unless weather conditions would prevent planting within that time period if the Board believes that such condition is necessary to satisfy the aesthetic criterion.
