DPS owned equipment/facilities utilized by the trooper(s) assigned to complete these services shall remain under the control of DPS.

SERVICES PROVIDED		
General police services. The Vermont State Police will enforce criminal and motor vehicle laws and ordinances on all lands and public highways within the town of East Montpelier, VT. They will patrol the roads to deter and prevent criminal activity, interact with the community, and foster the relationship between the residents of East Montpelier and the Vermont State Police, and other services as required. The number of hours each week and the time of patrol will be mutually agreed upon by the Vermont State Police Program Coordinator and the Selectboard Chairperson. This will adjust as needed and shall be subject to Vermont State Police availability. The Program Coordinator will also provide the Selectboard with an annual report.		
COMPENSATION		
The Client will be charged on a per hour basis. The rate will reflect the actual cost to the Department of the officer(s) providing services based on actual hours worked. The client agrees additionally to reimburse the Department of Public Safety for overhead costs. The overhead rate includes the operating and administrative costs that are attributable to all programs. The following types of costs are included in this rate: dispatching, vehicle operating, and administrative costs,
