To furnish and deliver all materials specified (unless otherwise noted) and to do and perform all work in accordance with the Plans and Specifications, and as specifically stated in the General Notes for the project, for the replacement of the existing structure, related channel work, and the limited reconstruction of the roadway approaches at the site on Town Highway 47, Murray Road in the Town of East Montpelier. Proposals will be received until 4:00 PM prevailing time on Monday, May 1, 2017, at the East Montpelier Town Offices, 40 Kelton Road, East Montpelier, VT. All proposals shall be sealed and shall be clearly marked as "Bid for Murray Road Project". The bids will be opened and read aloud at a selectboard meeting at the East Montpelier Emergency Services Facility (new fire station) located at 54 Village Acres on Monday, May 1, 2017 at 6:10 pm. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions. This project is situated as follows:

LOCATION: On TH 47, Murray Road, immediately adjacent to the town line between the City of Montpelier and the Town of East Montpelier

TYPE OF CONSTRUCTION: Closing the road to traffic; installation and/or construction of erosion prevention and sediment control measures, installation and/or construction of a temporary stream diversion, culvert or pump system; removal and disposal of the existing structure; assembly and installation of a new aluminum pipe arch, headwalls, cutoff walls, and wingwalls to the prescribed line and grade as shown on the plans; filling the invert with 2'-0" of Streambed Stone Fill, Type E2; backfilling and compacting around the new structure, headwalls and wingwalls; related roadway approach work including earthworks and the installation of guard rail, related channel work including the placement of geotextile fabric and stone fill, and turf establishment.
