Reclaim, place Calcium Chloride at 3/4 gallon square after initial reclaim, mix in Calcium Chloride with reclaimer, Fine Grade then cap with Calcium Chloride at 1/4 gallon square yard then Pave with 3" total depth of mix, consisting of a 2" depth of Type II mix "base course" and a 1" depth of Type IV mix "top or wearing course". To include 2' width of Shoulder Gravel where possible. Approximately 12,910 square yards.  
Reclamation with Finegrade 12,910 square yards at \$1.75 square yard = \$22,592.50  
Calcium Chloride approximately 12,910 gallons at \$1.25 gallon = \$16,137.50  
Paving approximately 2,175 tons at \$67.50 per ton = \$146,812.50

2. Muddy Brook Road 24' x 2,640' (from the Intersection of Route 2 to the T/O East Montpelier Vt./T/O Barre Vt. town line). Pave with 2 1/2" total depth of mix, consisting of a 1 1/4" depth of Type ~~IV~~ mix "shim course" and a 1 1/4" depth of Type ~~IV~~ mix "top or wearing course". To include 2' width of Shoulder Gravel where possible. Approximately 7,040 square yards.  
Paving approximately 1,000 tons at \$67.50 per ton = \$67,500.00  
Shoulders Lump Sum = \$5,520.00
