To furnish and deliver all materials specified (unless otherwise noted) and to do and perform all work in accordance with the Plans and Specifications, and as specifically stated in the General Notes for the project, for the replacement of the existing structure, related channel work, and the related reconstruction of the roadway approaches at the site on Town Highway 7, Quaker Road in the Town of East Montpelier. Proposals will be received until 4:00 PM prevailing time on Monday, June 4, 2018, at the East Montpelier Town Offices, 40 Kelton Road, East Montpelier, VT (USPS address: PO Box 157, East Montpelier, 05651). All proposals shall be sealed and shall be clearly marked as "Bid for Quaker Road Project". The bids will be opened and read aloud at a selectboard meeting at the East Montpelier Town Offices (address as noted above) on Monday, June 4, 2018 at 8:00 pm. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions. This project is situated as follows:

**LOCATION:** On TH 7, Quaker Road (also known as Quaker Hill Road), approximately 0.50 mile northwest of the intersection of TH 7 and US Rte. 2 in East Montpelier Village

**TYPE OF CONSTRUCTION:** Closing the road to traffic; installation and/or construction of erosion prevention and sediment control measures, installation and/or construction of a temporary stream diversion, culvert or pump system; removal and disposal of the existing structure; assembly and installation of a new aluminum pipe to the prescribed line and grade as shown on the plans, and the invert of the new structure with Streambed Stone Fill, Type E1; construction of reinforced concrete headwalls, backfilling and compacting around the new structure and headwalls; related roadway approach work including earthworks and subbase material, the placement of base, intermediate base and wearing surface pavement courses, new pavement markings, guard rail, related channel work including filling an existing scour hole, the placement of geotextile fabric and stone fill, and turf establishment.
