The Chair opened the hearing at 7:01pm by reading the warning: "Conditional use review of Application #16-038, submitted by Ashley Demers, to add a spa business use to the R & J East Montpelier LLC mixed use property located at 1528 US Rte.

2. The proposed day spa will be housed in the existing structure along with Demers Auto, a motor vehicle sales and service operation. The property is located in Zone B – Industrial, where a §4.11 mixed use requires conditional use review, and the Special Flood Hazard Area." The applicants were sworn in at 7:02pm. Ms. Demers would like to operate a day spa for no more than 5-10 hours per week, mostly after 5pm and on weekends. A wall will be added to the lobby area, as well as a separate entrance. The hours they are asking for is Monday through Friday 8am-5pm and Saturday 8am to noon for flexibility. There is no plan for a sign, but the ZA can approve one when necessary. There are no plans to expand with more employees. There will be plenty of parking; there should be no more than 2 cars at a time. The state has asked the applicants to pave 20 more feet of the driveway. No additional exterior lighting is planned. After discussion with the DRB, Ms. Demers revised her application to request operating hours of 8am-8pm on weekdays.

# Conditional Use Review of Application #16-047, submitted by Doug and Barbara Bragg

The Chair recused himself and asked Mr. Cueto to take over the meeting. Mr. Cueto opened the review at 7:43pm by reading the warning: "Conditional use review of Application #16-047, submitted by Doug and Barbara Bragg, to install a 16' x 12' storage shed at the Bragg Farm Sugarhouse and Gift Shop, located at 1005 VT Rte. 14N. The Braggs are requesting an amendment to Conditional Use Permit #91-029 (previously amended by Zoning Permits 94-097, 02-056, 06-110, and 13-040) which governs the commercial use of the property. The parcel is located in Zone D – Rural Residential/Agricultural, where neighborhood businesses require conditional use review." The ZA was sworn in by the Chair at 7:44pm.
