# <u>CVRPC Proposal for Village Master Plan and Zoning (2016 Municipal Planning Grant), Proposal by CVRPC Executive Director, Bonnie Waninger, and Senior Planner, Eric Vorwald</u>

Mr. Vorwald reviewed his proposed scope of work with the PC:

- ➤ Would there be a steering committee?
  - o The PC feels the whole PC should be involved, will invite outside members as warranted
- Tasks each one has a timeframe, deliverables and responsibility
- Public outreach will happen during the project, not at one specific time
- > Growth projections means putting numbers on agreed-upon scenario(s) and looking at possible zoning changes
- > Draft/final master plan will include pictures and graphics for clarity; will outline the vision for the village

#### Questions:

- ➤ What does the CVRPC need from the PC?
  - o Advocating for the project
  - o Identifying stakeholders
  - o Taking responsibility for public outreach
- ➤ Will CVRPC do an analysis of the Grand List?
  - o Not directly, but it will happen through the process
- > CVRPC will be looking at the uses and how they can support each other
- ► How often will we meet?
  - o At least monthly, maybe more often in the beginning
  - o PC would prefer reports digitally and a week in advance
- Public outreach ideas
  - o Ice cream social
  - Neighborhood potlucks

PC will invite members of the SB, Village Committee and Trails Committee to the kick-off meeting. The kick-off meeting was set for February 18, 2016 at the regular PC meeting. Mr. Vorwald will send a revised draft of the proposed scope of work and a contract prior to the PC's 2/4 meeting.

# BDE East Montpelier Lazar Solar, LLC 500kW Solar Array PSB CPG Application

The PC discussed the solar application and talked about filing a motion to intervene. Some of the PC concerns are:

- ➤ Utility poles can they be put underground
- > Equipment must be screened
- ➤ Clearing area (i.e., trees) needs to be clarified

Per Mr. Vorwald, the CVRPC doesn't feel it is a substantial regional project and reserves the right to comment on the project in the future.

Mr. Stout recused himself from the motion and vote.
