- Note other historical structures in Center Road area
- > Gallison Hill growth area: available land, access to sewer/water, close to commerce/Montpelier
- Ask ZA regarding number of units in Sandy Pines
- Next draft will be 3rd draft, essentially complete

# Water Supplies & Aquifers 2<sup>nd</sup> Draft (Erlbaum, Hopkins)

- Revised Current Status: public, private, groundwater
- Re-word goal #3
- ➤ Action discuss last one regarding conservation overlay
- ➤ Support formation of Fire District & provide encouragement
- Continued communication and coordination between Fire District and town officials re: land use & village planning matters
- > Sb, SB, and Select Board should be Selectboard consistently throughout the document
