Review Draft Conservation Overlay Map

The map uses the state's definitions of wetlands and waterways; the state looks at septic systems/water quality and the town looks at other potential sources of water contamination. The PC held a discussion regarding the language, districts versus areas. The decision was made to change the title of the map to "Conservation Overlay Districts" add "District" to the legend for Wetlands Overlay District, Well-Head Protection Overlay District and High Elevation Overlay District in a separate box titled Conservation Overlay Districts.

Review Zoning Changes Related to Section 9 References; Revised Flood Hazard Map

The PC reviewed the internal references in the zoning regulations.

Section 2.1(B) – specify correct map (Flood & Erosion Hazards Map); add "see Article 9"

Section 2.2(C) – add language regarding River Corridors from Article 9

Section 3.10, first paragraph - change Special Flood Hazard Areas to regulated hazard areas

Section 5.1(A)(3) – change to Flood Hazard Areas

Section 7.2(A) – change to Flood Hazard Areas

Section 7.3(A)(3) – change to Flood Hazard Areas

Section 7.3 (B)(2) – change to Flood Hazard Areas

Section 7.6(D) – reference Article 9

Section 7.8(G)(2) – change to Flood Hazard Areas, remove Section 8

Section 8 – under Substantial Improvement, refer to Article 9; make sure that Flood Hazard Areas is consistent with Article 9 Flood & Erosion Hazards Map –

- > crop out the other towns' areas/parcels
- > legend heading should be Regulated Flood Hazard Areas and change title of map to match
- > NFIP Flood Risk (2012) verify
