Discussion of Potential Merger of CVRPC & CVEDC

The PC reviewed a one-page summary of the proposed merger put together by Bruce Johnson and Tim Carver. The CVRPC may not be the same after the merger in terms of its representation of the town. Some of the major concerns put together by Julie Potter:

- Funding organization based on source of funding; no meaningful cost savings portrayed
- Sovernance members from 23 towns, 9 members from CVEDC plus 3 at-large members; revenue doesn't seem equitable base on representation; too many members from CVEDC
- > Reason for merger report doesn't make reasons for merger very clear for either organization

The PC is comfortable with giving these comments to the SB; Julie will send to Bruce Johnson. There is an open CVRPC meeting on 5/14 for a merger discussion.
