- > The Word document (longer) will be used as the Guide on the website
- Answer to why PC is creating new regulations protecting property owners and the town
- > Actions:
 - o Mention flood regulations in place since 2008; being updated/improved because of state regulations
 - o Add short sentence regarding ERAF (increased assistance/more money)
- > Property owners actions:
 - o Flood insurance condense to 1st paragraph
- > More information
 - o Change to bullet points; put EM website first
 - o Remove 'also' in numerous places
- > Add Natural and Beneficial Functions to the brochure; maybe right before More Information section
