East Montpelier 2018 Town Plan Update

The PC reviewed several sections of the current Town Plan and made the following suggestions for revisions/additions:

A Look at the Town – Norman Hill

- Mr. Hill suggested some different language regarding the Abenaki Indians
- > Typo on page 10 insert 'to' between 'began' and 'survey'
- ➤ Ms. Potter has Excel spreadsheets for charts on page 12 Mr. Hill will research US Census data site
- ➤ Page 13 get job figures from Vermont Department of Labor

East Montpelier and the Region - Julie Potter

- > The section that mentions regional organizations has mixed types of organizations and is missing some; Ms. Potter suggested the social services organizations be moved to the Social Services section
- Comparison of Town Plans needs to be updated
- Actions PC should meet with other towns prior to completing the Town Plan
- Concerns throughout the plan some goals sound like actions and there are too many actions
 - o Suggest fewer goals
 - o May need more policies
 - Look at opportunities
 - o Ms. Potter suggested a new section that deals with focused, priority action items, detailing how they will get done
- ➤ Page 13 Current Status, first paragraph change wording after "It is fair..."
- ➤ Page 14 add suggested language from Mr. Hill
- ➤ Page 17 Future Challenges re-word the last sentence

Town Government - Norman Hill

- Current Status re-word section on Fire District; also referenced on page 90
- Include paragraph on website before Elected Officials
- > Elected Officials remove those who are now appointed and add to Appointed Officials section
- > Include Capital Improvement Committee under Appointed Officials section
- > Distinguish paid versus volunteers
- ➤ Change the Recreation Board description
- ➤ Rally Day can reference it but note that it is currently dormant
- Actions delete #4, #5 and #8

Finance – Jay Stewart

- > Data needs to be updated
- > Act 46 school consolidation reference here but add specifics in the Education section
- \triangleright Page 24 2nd paragraph check with Treasurer on consolidating
- ➤ Page 25 farm contracts program has changed, can probably be removed
- Consider referring to 'current Town Report' instead of listing specific figures
- ➤ Goals delete #3
- Consider streamlining goals/actions throughout the Town Plan

- Embellish the paragraph that references Front Porch Forum
- Re-wrote section on Four Corners Schoolhouse
- ➤ Remove reference to farmers check with Bruce Chappell
- ➤ Remove Rally Day and town website paragraph
- Expand SignPost and EMSLI paragraphs
- ▶ Jean Cate Fund Mr. Hill will check to see if they still produce the booklet on the town
- ➤ Page 31 change Forest Committee (not Forestry); add Old LaPerle Farm Committee

Recreation Committee - Ray Stout

- ➤ Carleton Smith Fund will check with Treasurer
- ➤ Swimming lessons Mr. Stout will check with someone on the Recreation Board
- ➤ Will add reference to non-profit status
- Add expanding existing rec space
- > Consider adding reference to Montpelier Senior Center and Twin Valley Senior Center, exercise classes at Four Corners
- ► Include activities, not just facilities; at U-32, add the tennis courts

- ➤ Update boxes of information on page 38-39
- Mention challenge of high-speed internet

- Resources update wastewater language; remove paragraph on North Montpelier
- ➤ Page 40 update sidewalk paragraph
- Future incorporate Village Master Plan; add, "PC and Village Committee worked to enhance..."
- ➤ Goals delete #3
- ➤ Actions delete #8
- > Include paragraph on PC developing Village Master Plan

Historic Resources - Jack Pauly
