East Montpelier 2018 Town Plan Update: Future Land Use Map: Presentation and Discussion with Eric Vorwald, CVRPC

Presentation by Mr. Vorwald:

- ➤ This is an aspiration exercise what could happen in the future, not what will happen
- > Zoning must conform with municipal plan
 - o Identifies uses
 - o Dimensional standards
 - o Allowable, conditional, prohibited uses
 - Distinct boundaries
 - o Addresses current land uses and planning
- ➤ How far in the future could have short-term and long-term maps
- ➤ Land use shall consist of map and statement could set up future zoning changes
 - Aspirational
 - o General use categories
 - Municipally defined categories
 - o Ambiguous boundaries
 - o Indication of how community may change
- > Samples of different land maps:
 - o Ambiguous/arbitrary boundaries South Burlington
 - o Specific sections Bolton
 - o Good example to look at Hubbardton
- Map shouldn't have to be updated too often
- Village Master Plan is a good place to start
- Growth centers may have ambiguous boundaries
- Ms. Potter suggested more ambiguous than hard boundaries
- Ms. Vissering/Ms. Potter will work with CVRPC to have a sample map at the next meeting

East Montpelier 2018 Town Plan Update

The PC reviewed several sections of the current Town Plan and made the following suggestions for revisions/additions:

Forest Resources - Mark Lane

- Page 72
 - o History remove figures
 - o Current Status need to add piece on Coburn Road; change 'well-managed' to 'actively-managed'; update figures on Current Use and land conservation; CVRPC can help with forest figures
- Page 73 update figures and trim some language
- ➤ Whole section needs headings
- Add discussion on forest defragmentation
- Last 2 paragraphs of the section move to the beginning and condense
- ➤ Goals delete #2, #7, #10; include timber harvesting

Update on East Montpelier Old LaPerle Farm Property Committee

With a \$10,000 grant, the committee has hired an engineer to do a feasibility study and financial analysis of the property. Ms. McFadden came to the PC to talk about preserving the old house on the property. She feels it is a great historical piece of the village and feels it would be hard to replicate. The windows that were removed need to go back in and she would like to have a work party in November to secure the building until all the construction around it has been completed. The building anchors the corner and Ms. McFadden would like to see it preserved.
