#### <u>Discussion of Draft Municipal Planning Grant Application Prepared by CVRPC for the Development of Fluvial Erosion</u> Hazard Regulations

Kim McKee of the CVRPC drafted the Municipal Planning Grant application and reviewed it with the PC. The Fluvial Erosion Hazard bylaws would cover smaller streams that are not covered by other flood regulations. The CVRPC utilized the Town Plan and the zoning regulations. The CVRPC can host and facilitate a public forum, send out invitations and coordinate with ANR staff. It is pretty likely that the town would get the grant because fluvial erosion is becoming a top priority for the state. The town would hire a consultant to draft new regulations and possibly create a new overlay.

Page 3 – 5) position town for greater financial assistance for future flood events

Page 5 – c) VCD renewal planned for 2014, clarify Kingsbury Branch, will enable town to receive higher compensation under ERAF

Page 4 – refreshments at public forums, add a reference to Front Porch Forum

Page 10 – fix auto calculation; review other places, as well
