East Montpelier 2018 Town Plan Update: Reports on Recommended Changes to the Following Sections of the Town Plan: Energy & Energy Conservation, Land Use Patterns and Zoning, Villages and Growth Areas, Housing, Agriculture, Wastewater Disposal, Appendices

Energy Committee Update – from Lindy Biggs

Because of Act 174, if the town writes an Energy Plan and it is incorporated into the Town Plan, the town will get substantial deference in front of the Public Service Board, now the Public Utility Committee. There are four parts of the plan: efficiency, transportation, land use and siting. The Energy Committee has a draft of all four sections. The PC will incorporate some of the language in the Town Plan but also include the full documents as an attachment. The draft needs some fine tuning and the Energy Committee will work on the re-write off the sections.

Transportation – Ray Stout

- ➤ Page 56 add traffic study of Gallison Hill/Towne Hill/Brazier Road
- Page 57 Collector road information is available in the profile of the Village Master Plan; add language on traffic speed concerns
- ➤ Page 58 add Park N Ride; include link to public transportation sites
- ➤ Page 60 update budget figures; confirm Class 2, 3 and 4 roads; mention the bridge project; Regional Coordination section Frank Pratt is the town representative

Land Use Patterns and Zoning - Jean Vissering

- Must include a future land use map the PC agrees to include the village, industrial, conserved land, growth areas and rural residential, as well as the high elevation overlay and the Town Forest
- ➤ Page 94 change 'current' to 'existing'; change acreage figures
- Page 95 change Conservation Area Overlay District; include Flood Hazard Mitigation; include a new section on Future Zoning Districts
- Goals/Actions will be tweaked; think about putting policies in this section and the Energy section; look at Regional Plan for ideas
- ➤ Villages & Growth Areas very redundant
- ➤ Maps include existing districts/zoning; include proposed village plan map

Housing – Julie Potter

- Updated the following figures housing stock data, household size, median price in the Cost & Affordability section
- New paragraph on Regional Housing Distribution Plan
- ➤ Goals/Actions created new items: 4 goals and 6 actions
