Review of Draft Flood Hazard Area Regulations - Focus on "Minimal Investment"

- The PC discussed the wording "minimal investment" in Section 9.5(D)(8) and talked about whether to include a dollar figure or not. Some states use a \$3,000 or \$5,000 ceiling. The PC decided to leave the language as "minimal investment" without a dollar figure.
- > Section 9.11 was removed but the PC decided to reinstate it
- ➤ Maps
 - o Based on the most current data
 - o PC will meet in January with Sacha Pealer and Dan Currier to get explanations on the new maps
- Trails related to Section 9.4
 - o Trails are not regulated currently unless a bridge is needed in which case the bridge would be a structure
 - o Is a paved trail considered a structure? Would impact run-off and include more construction
 - o No need to restrict foot paths in the floodplain
- ➤ Section 9.3(A)(3) include mention of Section 3.12 in terms of a 25-foot vegetated buffer; add "See Section 3.12 of the general zoning regulations
- ➤ Timeline consider holding a PC meeting on 1/8, then 1/15 or 1/22; the Chair will try to schedule guests (Sacha, Dan, Rick Hopkins) at one of these meetings

Review of Draft Table 2.6 Conservation Overlay District

The table is being revised along with the new Article 9. The PC needs to decide if Section B is needed because it is mostly covered in Article 9. The PC would like to have two maps in conjunction with Table 2.6: one for rivers, streams and floodplains and one for wetlands, water supply sources and high elevations. The Chair will contact Dan Currier regarding creating the new zoning maps for new Table 2.6. The table needs to more clearly state what needs a permit: permitted uses versus conditional uses. The PC will re-visit at a future meeting: creating a new district or clarifying current Table 2.6.
