## Continuation of Discussion of Items for Revision to Zoning Regulations

Section 4.6.2 – Withdrawal of Groundwater Resources

Discussion:

- > Reviewed list of EPA business water uses; reporting requirement is 20,000 gal/day; what uses fall under this requirement
- ➤ PC would like more facts re: bottling plants and breweries; Chair will contact the state re: the 20,000 gal requirement Chair reviewed comments from Scott Stewart in the state's groundwater division. No action was taken at the time on any of Scott's suggestions/comments.
  - Table 2.6 aquifer protection area is now referred to as the source water protection area (i.e., Berlin Pond, EMES's well)
    - o Conservation overlay replace green aquifer areas with the blue wellhead protection areas
    - o Concern would be source protection, water quality of the rivers/stream/ponds, critical habitats
    - o Septic systems are allowed in wellhead areas with state oversight
    - o Combine groundwater favorability area, wellhead protection areas, water, wetlands, wildlife habitats, natural resources on the same map
    - o Revise Table 2.6 (pg 15) and Conservation Overlay
    - o Consider creating a conservation district
  - ➤ Table 1.1 Wastewater add water systems, public or potable, on-site water source
  - ➤ Section 4.6.1(A)(B) on-site/off-site, size of project, extent of impact
  - > Section 4.6.2 strike "including spring water", strike "subject to state's public trust provision"
    - o (B) how far does DRB look off-site?
    - o (D) strike "individual or domestic", change to "drinking"; PC decides to leave the language as is
  - ➤ Section 5.2(A)(4C) water source overlaps parcels should be addressed
  - $\triangleright$  Section 5.4(E)(6) strike "municipal"
  - Section 6.9(C)(1) include public or potable water systems, change "well head" to "well shield"; include well shield in parentheses or add to definitions
    - o (C)(2) designate "water supply protection areas", strike everything after "plat"
    - o (C)(3) change "existing well shield distances"
  - > Be consistent throughout well shield, well head protection, isolation distance, source water (SPA), aquifer protection areas; check with state for official definitions
