Excess Weight Permit

Road Foreman (RF) Report

- The village sidewalk scoping study funded by a FY11 VTrans Transportation Enhancement Grant is nearing completion and may recommend a two-phase sidewalk project. In order to apply for a FY13 VTrans TEG for a design & construction project the town must submit a letter of intent by mid-July. The actual application is due in October. RF thoughts on sidewalks: more maintenance and harder to plow, especially with a green strip.
- VTrans Paving Grant town received a \$175,000 grant for the repaving of Center Road. The RF wanted to know whether he should schedule the paving this fall or wait a year; the SB suggested he tentatively schedule Pike for September.
- VTrans Structures Grant Program town did not receive a grant. Two projects were applied for: Quaker Road culvert upsizing SB decided to apply for another grant next year; Dodge Road culvert replacement culvert needs repairing; the RF received a \$30,000 quote from Dubois Engineering to replace; SB suggested he evaluate other options first.
- ESF Ditch EMFD asked who is responsible for mowing the ditch line; the town is and may ask Tim Frazier to do it.
- Templeton Road Fire Station EMFD would like the lot paved; RF will inspect lot, talk with Pike and get back to the SB.
- Discussion on sight line problems at base of East Hill Road at VT Rte 14 N intersection.

Motion: I move to enter executive session to discuss a potential legal matter. Made: Etnier, second: Gardner Vote on Motion: Passed 5-0

SB entered executive session at 7:15pm and exited at 7:40pm. No action was taken.

Discussion on Public WiFi at the Town Office

As part of the network upgrade the town will purchase a wifi-capable router. The network server will be walled off from the public wifi. There was discussion on whether to make the wifi password protected. Cons – lose control over access; speed could suffer. Pros - password not required. The SB agreed to leave it open for now, but it can be changed at a later date.
