
2. THE MAPPING OF THE PORTION OF THE PROPERTY LYING WEST OF ROUTE 2 IS BASED ON PLANS OF THE OLD ROUTE 2 RIGHT-OF-WAY A PROVIDED BY VTRANS, A PLAN OF THE FORMER "F. GARFIELD LAND AREA" AS FILED IN MAP SUDE #G OF THE EAST MONTPELIER LAND RECORDS AND AN AERIAL PHOTOGRAPH OF THE LIMITS OF THE WINOOSKI RIVER.

3. THE LIMITS OF THE SPECIAL FLOOD HAZARD AREA IS BASED ON THE MOST RECENT F.E.M.A FLOOD INSURANCE STUDY OF THE WINOOSKI RIVER, HAVING AN EFFECTIVE DATE OF MARCH 19, 2013. NOTE THAT THE ENTIRETY OF THE PROPERTY LYING WEST OF ROUTE 2 IS WITHIN THE REGULATORY FLOODWAY.

4. THE RIGHT-OF-WAY OF ROUTE 2 IS BASED ON PLANS PROVIDED BY VIRANS RIGHT-OF-WAY UNIT AND MONUMENTATION FOUND.

5. THE EXISTING DRILLED WELL, INSTALLED BY THE FORMER OWNER, IS LOCATED WITHIN THE ROUTE 2 RIGHT-OF-WAY AND MUST BE REPLACED WITH A PROPERLY LOCATED WELL TO SERVE THE EXISTING/PROPOSED USES, UPON RECCIPT OF LOCAL APPROVAL, AN AMENDED STATE WASTEWATER PERMIT WILL BE SOUGHT TO PERMIT THE REPLACEMENT WELL AND TO CODIFY THE USES AS DEPICTED HEREON AS THOSE COVERED BY THE PERMIT. THE EXISTING/PROPOSED USES REPRESENT A SIGNIFICANT REDUCTION IN DAILY SEWER AND WATER FLOWS AS COMPARED TO THOSE PERMITTED FOR THE FORMER CAMPGROUND AS 16 STILL IN EFFECT.

G. WITH THE EXCEPTION OF EXCAVATION NECESSARY TO ROUTE A WATERLINE FOR THE NEW WELL, NO EARTH DISTURBANCE OR OTHER DEVELOPMENT IS PROPOSED BY THIS PROJECT.
