The Central Vermont Regional Planning Commission (CVRPC) received a petition on behalf BDE East Montpelier Lazar Solar, LLC for a Certificate of Public Good on January 5, 2016. This petition is for the construction of a 500 kW net metered solar array with interconnection to Green Mountain Power. This project proposes access from U.S. Route 2 through an access easement and is located directly adjacent to the existing boundary of the Village of East Montpelier which is a State Designated Village Center.

On January 21, 2016, the CVRPC's Project Review Committee met and discussed this project in relation to consistency with the Regional Plan and the possibility of this project meeting the thresholds for Substantial Regional Impact. At this meeting, the Project Review Committee determined that the above referenced project does not currently qualify as project having Substantial Regional Impact as noted in the CVRPC's policies and procedures. As such, the CVRPC does not intend to submit testimony on this project. However, the CVRPC reserves the right to reevaluate this project and provide comments if conditions or circumstances regarding this petition were to change.
