Discussion with Joseph Kiefer, Food Justice Consultant: Food Security Planning

Mr. Kiefer stated that the Farm to Plate initiative started 7 years ago with a goal to decrease the amount of food imported into Vermont from 95% to 90% within 10 years. Currently, the amount of local food is at 10% and growing. Mr. Kiefer is a part of the Food Access Team, whose responsibilities include making sure everyone has access to local food, and education (growing, cooking, preserving). Mr. Kiefer then reviewed the history of food security in Vermont. He talked about food assessment planning at a local level. There are resources available: Waterbury-Duxbury (integrated into their Town Plan), NE Kingdom (regional food system planning) and Bennington (completed food access survey). Ms. Potter asked about funding sources for the town. Mr. Kiefer was not sure but mentioned the NE Grassroots Environment Fund as a possible source. He noted that the Vermont Foodbank is purchasing more local produce than ever before. The PC is interested in exploring food-centric planning. Mr. Kiefer reviewed some of the Town Plan sections and found some areas where language on "food security" could be added. He gave his suggestions to the Chair. There was discussion of the definition of "local." Ms. Watson felt that it was within a 3-hour driving radius. Ms. Potter suggested considering creating a Food Committee.

East Montpelier 2018 Town Plan Update: Review of Formatted Draft 2018 Town Plan Sections: Front Matter, Chapters 1-5

- The new TP will have one-column design, instead of two-column, with 12-point font

- Last section will have an implementation table of all the actions

<u>Discussion on Upcoming Planning Commission Meeting Schedule: Special Meeting on December 14, 2017, Consideration of Decision to Hold or Cancel the December 21, 2017 Meeting</u>

The PC agreed to hold a special meeting on 12/14 to review the rest of the Town Plan draft and the maps in draft form. The PC further agreed to cancel the 12/21 meeting. There was a discussion on the public meetings on the Town Plan: one of January 18, 2018 and one on February 1, 2018. The meetings will consist of a small presentation and receipt of public comments. The meetings can be pushed back if the plan is not ready. There was some concern among the PC on whether the Energy Plan and the Energy section will be ready on time; the PC needs to get some clarification on the Energy Plan approval process. For a March 8, 2018 hearing, the 30-day warning date is February 5, 2018; the plan would then be passed on to the SB on March 19, 2018.

Presentation of 2018 Municipal Planning Grant Conceptual Schedule

Ms. Potter noted that we must send this out for bids for a consultant; we cannot simply hire the CVRPC. She will talk with the ZA regarding creating an RFP (Request for Proposal). The PC will review the proposals that are submitted.

No update; they will not meeting until the test pits are completed.
