They would like the plans for taking care of animals in emergencies in the town's emergency plans and are currently working on a plan for East Montpelier. The plan will be an addendum to the town's local emergency operations plan; it can be added to the new plan which will be adopted in April 2018. DART fits in nicely with FEMA. There are no plans for large animals at the moment. The plan will be reviewed by the SB on April 23, 2018.
