Discussion on FY2020 Budget Development

- The town's CLA dropped to 95.32% from 95.83%; this will create a slightly increased upward pressure on the 2019/20 education tax rate
- The CLA drop also pushes our projected Washington County tax up slightly to \$25,074; the annual Washington County budget meeting is set for January 18th, 3 p.m. at the clerk's office in Montpelier; the final tax figure will be set thereafter, but no change is expected
