Consideration of Options for Certificates of Deposits for Cemetery Perpetual Care Fund & General Fund

- Utilizing the funds from maturing cds at Northfield Savings Bank, the board authorized the purchase of two cds in the amounts of \$160,000 (general fund) and \$75,475 (cemetery perpetual care) through NorthCountry Federal Credit Union at its January 20th meeting; as it turned out, the town could not purchase the two cds due to a \$250,000 limit on cds at NCFCU (we already have two cds with a total value just over \$70,000 at NCFCU)
- Treasurer Welch is recommending an alternative approach:
 - o Putting the \$75,475 perpetual care funds in a new cd at NCFCU (two years; 1.75%)
 - o Putting \$160,000 from general fund back into a cd at Northfield Savings Bank (9 months; 1.50%)
 - Current People's Bank general account is earning 1.05%; rates have been dropping over the past few months, but this may be the floor for now
- Checks matching the treasurer's recommendation are on the warrant; either or both can be voided dependent on the board's decision
