Discussion with Vermont State Police; Consideration of 2019 State Police Contract

- Middlesex Barracks Commander: Lt. David White
- EM contact/contract manager: Sgt. Charles Winn
- New contract will be for a one-year period, but only 20 hours/month instead of the regular 40 hours; \$75.69/hr, a 5.7% jump over last year's \$71.61
- We've been provided about one-third the contact time authorized under the current contract due to issues with trooper availability; at a meeting with Sgt. Winn on January 16, 2020, a plan was developed to try a 20 hour/month contract to see if trooper coverage ability improved
- Board should authorize Chair Gardner to sign contract

Discussion on Town Management in Light of Covid-19: Town Health Officer Ginny Burley

- Board should make some basic decisions:
 - o To close the town offices to the public effective immediately and until further notice
 - The staff will be available to provide assistance by phone and email
 - Land research may occur by appointment only
 - o To cancel all non-essential board/committee meetings and events
 - In particular, this would mean canceling the Easter Egg Hunt, scheduled for April 4th at the recreation field
 - Board should consider cancelation of its already-rescheduled March 30th meeting; the April 13th meeting should be held
 - o To authorize leave flexibility to ensure the safety of office personnel all of whom meet the definition for high risk
 - VLCT has put out an opinion that it is allowable for a town to waive the late dog registration fee (a statutory fee that stays with the town); Town Clerk Laquerre is requesting that the board authorize the waiver
- A concern circulating through EM and other communities is how to assist those in need; although the classic "good neighbor" concept remains the gold standard, some would like a more structured approach; there are model "I can help" or "I need help" documents that the town could put out to provide the relevant information; THO Burley & TSO Grossman are collecting offers and needs now
- Another topic that is starting to gain steam is the need for some sort of relaxation of late tax payment penalties; this is more of an FYI, as these are town voted penalties, so the only clean way to waive them is individually through the tax abatement process; more on this topic to come

Discussion on Creation of Conservation Commission

- Now that the town voters have authorized the creation of an EM Conservation Commission, the board needs to decide how to move this forward; in particular:
 - O How large a commission (range from 3 to 9 members)

- Whether to simply create the commission and advertise for members, then allow the members to develop the policies & procedures for the commission (subject to SB approval), or to do the development work ahead of the creation
- o Target timeframe for formal creation (now would not be the time in light of Covid-19)

Discussion on East Montpelier Hosting Autonomous Vehicle Testing by VTrans

• VTrans is looking for towns in which to do testing; if the board has interest, it should designate the roads/road segments that may be used; this authorization can be modified/revoked at any time

Consideration of Resolution in Support of Community Transit Week 2020

- CVRPC & GMT are asking towns to adopt resolutions in support of the May 2-8, 2020 Community Transit Week
- The planning hearings on the proposed changes to the GMT routes have been postponed due to Covid-19; the feedback process, however, is continuing see notice

2020 Selectboard Organization

- At a minimum, board needs to elect a chair and vice-chair
- Should also authorize a member to sign payroll warrants, payroll vendor warrants, and necessary expense warrants (when due dates don't align with meeting dates; rarely happens)

2020 Selectboard Rules of Transaction
