The Chair opened the hearing at 7:01pm by reading the warning: "Review of Application #20-002, submitted by Erin O'Hara and Lindsay Helwig O'Hara, to construct an addition, which will increase the footprint by 360 square feet, to their house located at 1283 North Street. The applicants are requesting a 10-foot §3.14 side setback waiver. The property is in Zone D – Rural Residential/Agricultural district, where the side setback is 50 feet." The applicants were sworn in at 7:02pm. The applicants currently live in a tiny house of about 400 square feet. They would like to start a family, as well as build a more solid foundation. The neighbor to the north had had concerns with the property in the past but apparently is supportive of this project. There is a covered landfill on the property; VT ANR is aware and nothing appears to be toxic. The expansion would allow the applicants to look away from the closest neighbor to the south, which is about 125 feet away. The applicants have considered changing the plans to reduce the footprint but haven't finalized anything yet.
