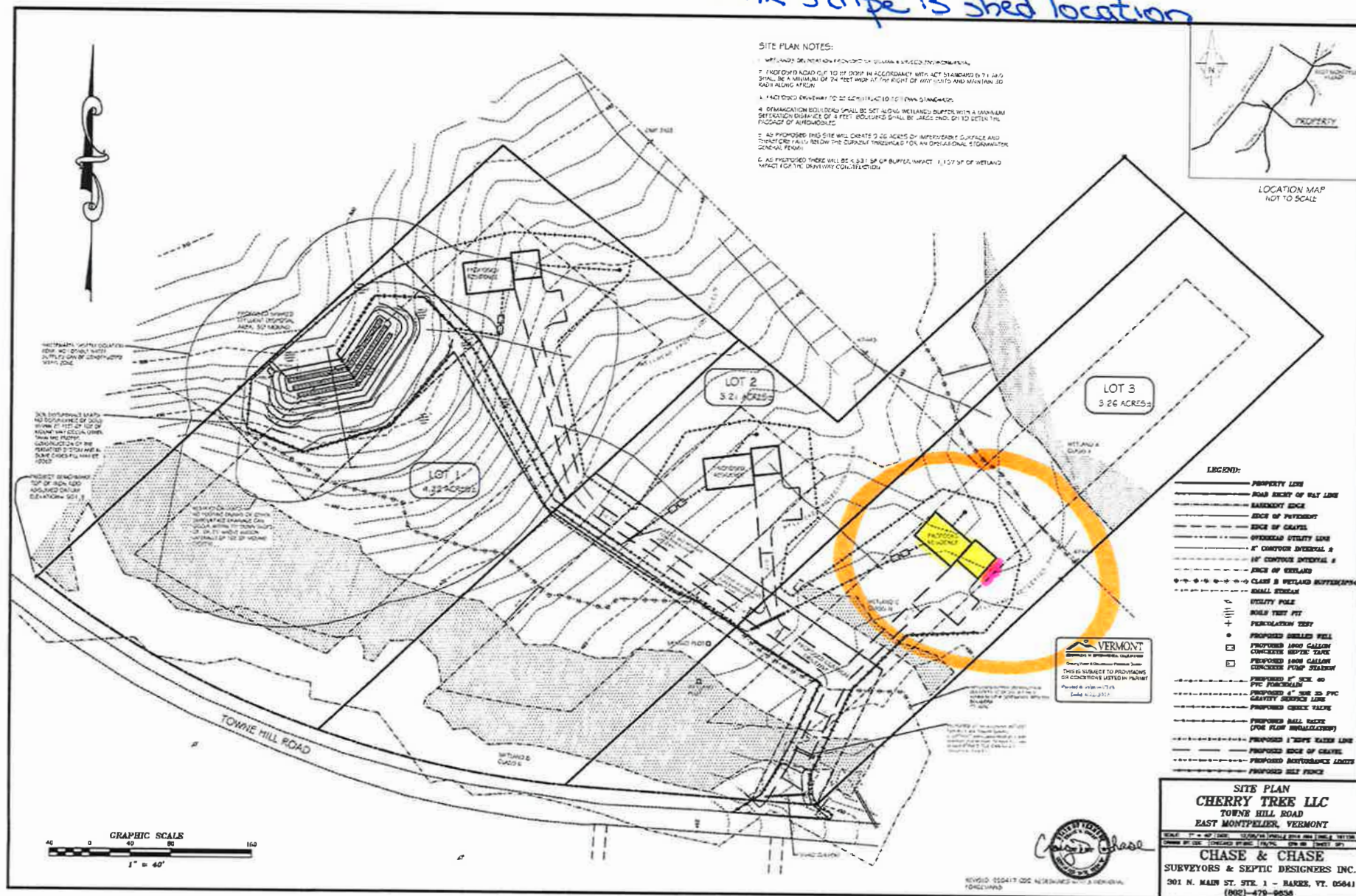
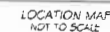
1. "Participation" in a DRB proceeding shall consist of offering, through oral or written testimony, evidence of a statement of concern related to the subject of the proceeding.
2. The notice of appeal shall be filed by certified mailing, with fees, to the Environmental Division of the Vermont Superior Court and by mailing a copy to the East Montpelier Zoning Administrator, who shall supply a list of interested persons (including the applicant if not the appellant), to the appellant within five (5) working days. Upon receipt of the list of interested persons, the appellant shall, by certified mail, provide a copy of the notice of appeal to every interested person. If any one or more of those persons are not then parties to the appeal, upon motion they shall be granted leave by the court to intervene.





SITE PLAN NOTES:

1. FRODOBEN AGED UP TO 10' TO 12' IN ACCORDANCE WITH ACT STANDARDS IN 7.1.5 SHALL BE A MINIMUM OF 4" FEET WIDE AT THE TOP OF 600' STOPS AND MAINTAIN 30' DIAL ALONG AFRICA
2. FRODOBEN DISTANCE TO BE 60' TO 120' IN THE STATION
3. DEMONSTRATION BUILDING SHALL BE SET ALONG THE WETLAND BUFFER WITH A MINIMUM SETTLEMENT DURATION OF 4 FEET. BUILDINGS SHALL BE JAGS ONLY TO GET THE PROTECT OF ALPHABETICS
4. AS PROPOSED THIS SITE WILL EXIST 2' TO 3' OF IMPERMEABLE SURFACE AND THEREFORE FULLY MEET THE CURRENT THRESHOLD FOR AN OPERATIONAL SUSTAINABILITY AND PROTECT
5. AS PROPOSED THERE WILL BE 0.31' OF BUFFER IMPACT 1.157' OF WETLAND IMPACT FOR THE DRYLAND COEXISTENCE







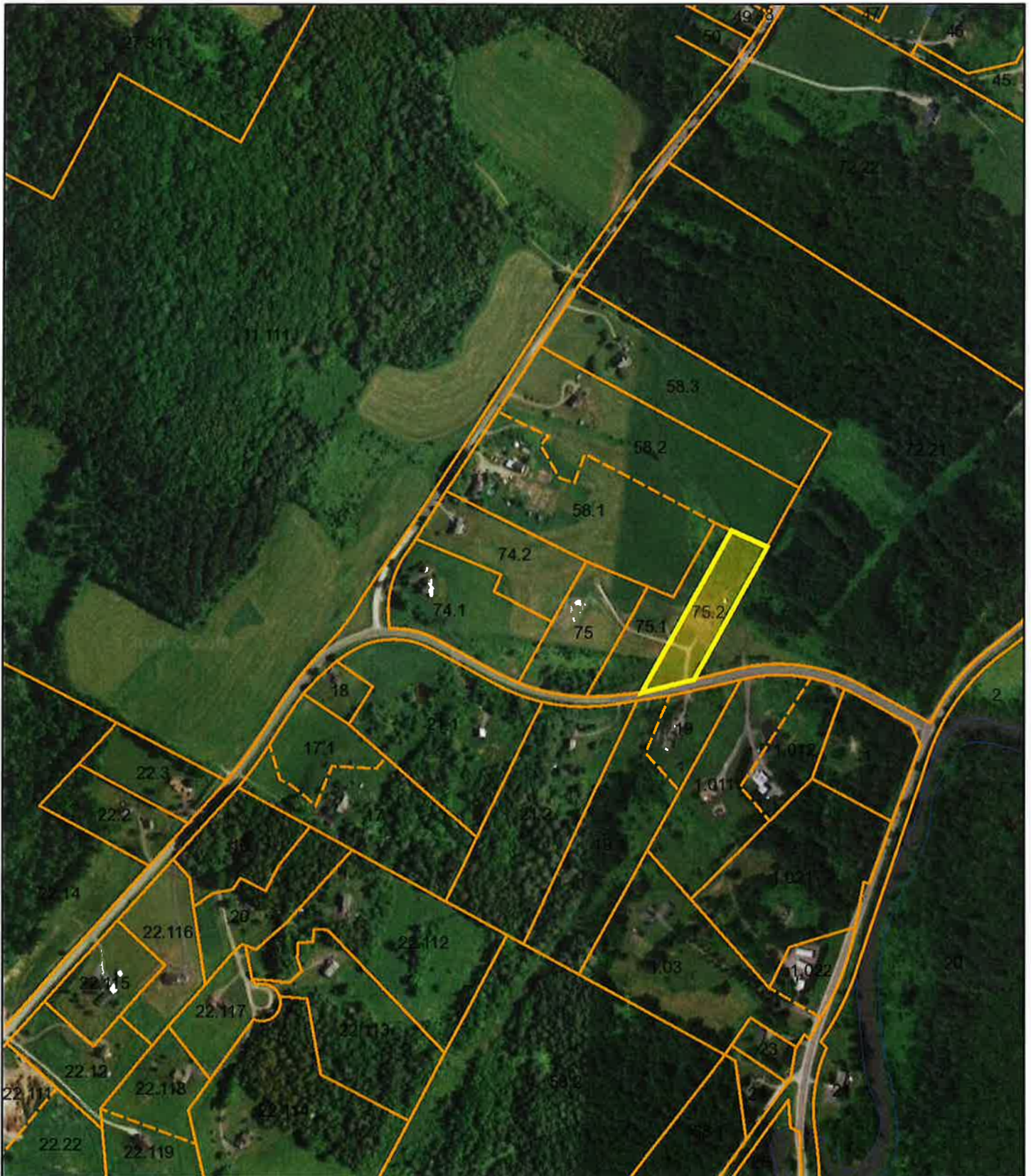
# Basic & Bikic -- 30 Deerfield Lane
