On November 12, 2020, New Cingular Wireless PCS, LLC d/b/a AT&T ("AT&T") submitted an Advance Notice pursuant to 30 V.S.A. § 248a to explore the viability of constructing a new communications support structure and wireless communications facility (the "Project") on property located at 750 Jacobs Road, East Montpelier, Vermont, on land owned by Robert and Diane Fusco. On December 9, 2020, the Town of East Montpelier (the "Town") submitted to the Public Utility Commission pursuant to Section 3 of Act 125 of 2020 a request for a 30-day extension of the advance notice period. The Commission issued a Memorandum as of today granting the 30-day extension. Separately, AT&T has agreed with the Town to an additional 30-day waiting period, extending the total time for the advance notice period to 120 days.

The Town has set a date and time of **Thursday, January 14, 2021 at 7pm** for a public information session via Zoom regarding the Project. AT&T plans to make a presentation at that time, and host questions from public officials and the public at large, all with the Department of Public Service representative in attendance.
