

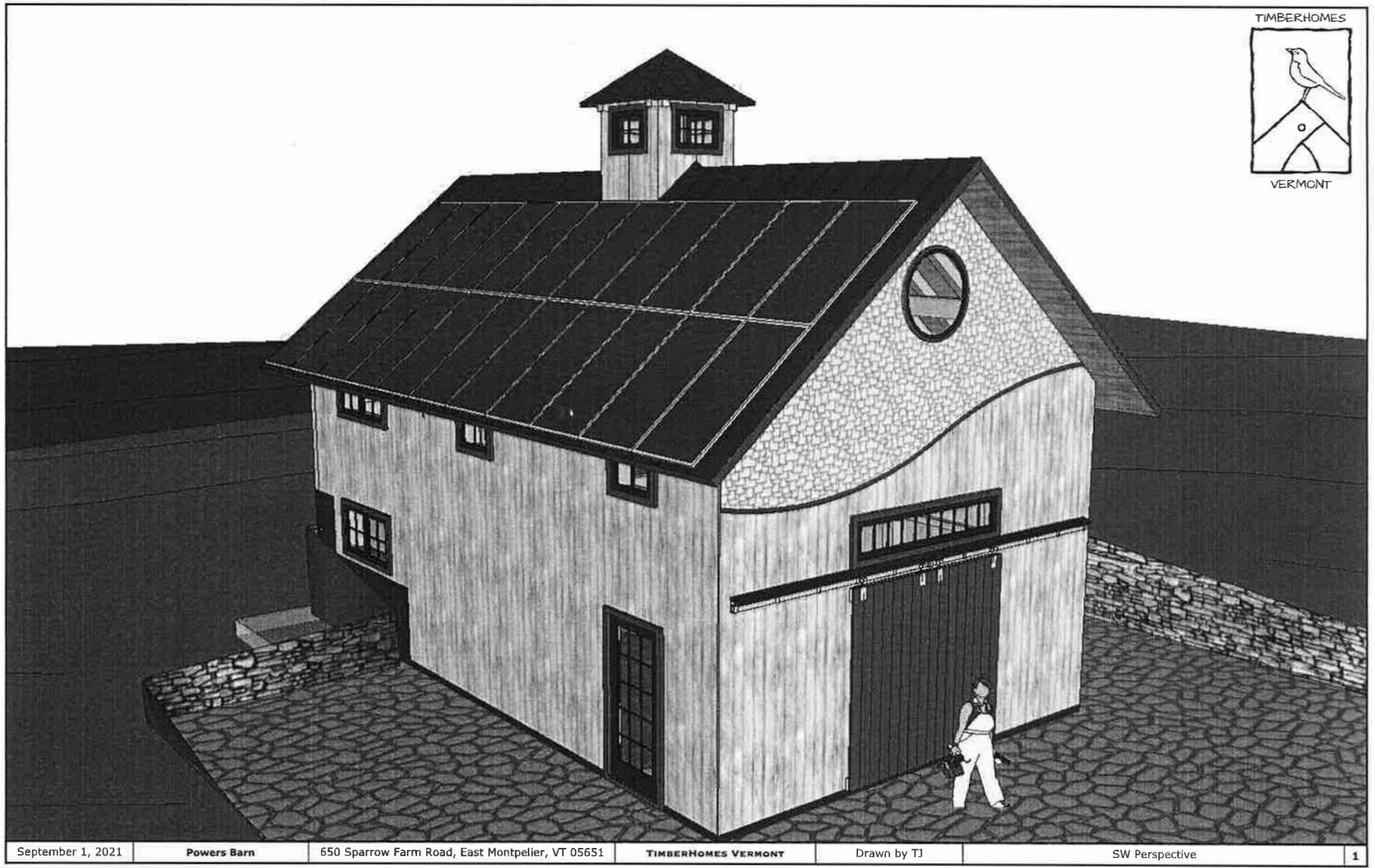

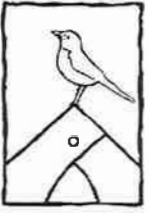

The applicant, appellant or other interested person who has participated in a regulatory proceeding of the DRB may appeal the decision rendered by the DRB within 30 days of the issuance of such decision, to the Environmental Division of the Vermont Superior Court, in accordance with 24 V.S.A. §4471.

1. "Participation" in a DRB proceeding shall consist of offering, through oral or written testimony, evidence of a statement of concern related to the subject of the proceeding.
2. The notice of appeal shall be filed by certified mailing, with fees, to the Environmental Division of the Vermont Superior Court and by mailing a copy to the East Montpelier Zoning Administrator, who shall supply a list of interested persons (including the applicant if not the appellant), to the appellant within five (5) working days. Upon receipt of the list of interested persons, the appellant shall, by certified mail, provide a copy of the notice of appeal to every interested person. If any one or more of those persons are not then parties to the appeal, upon motion they shall be granted leave by the court to intervene.

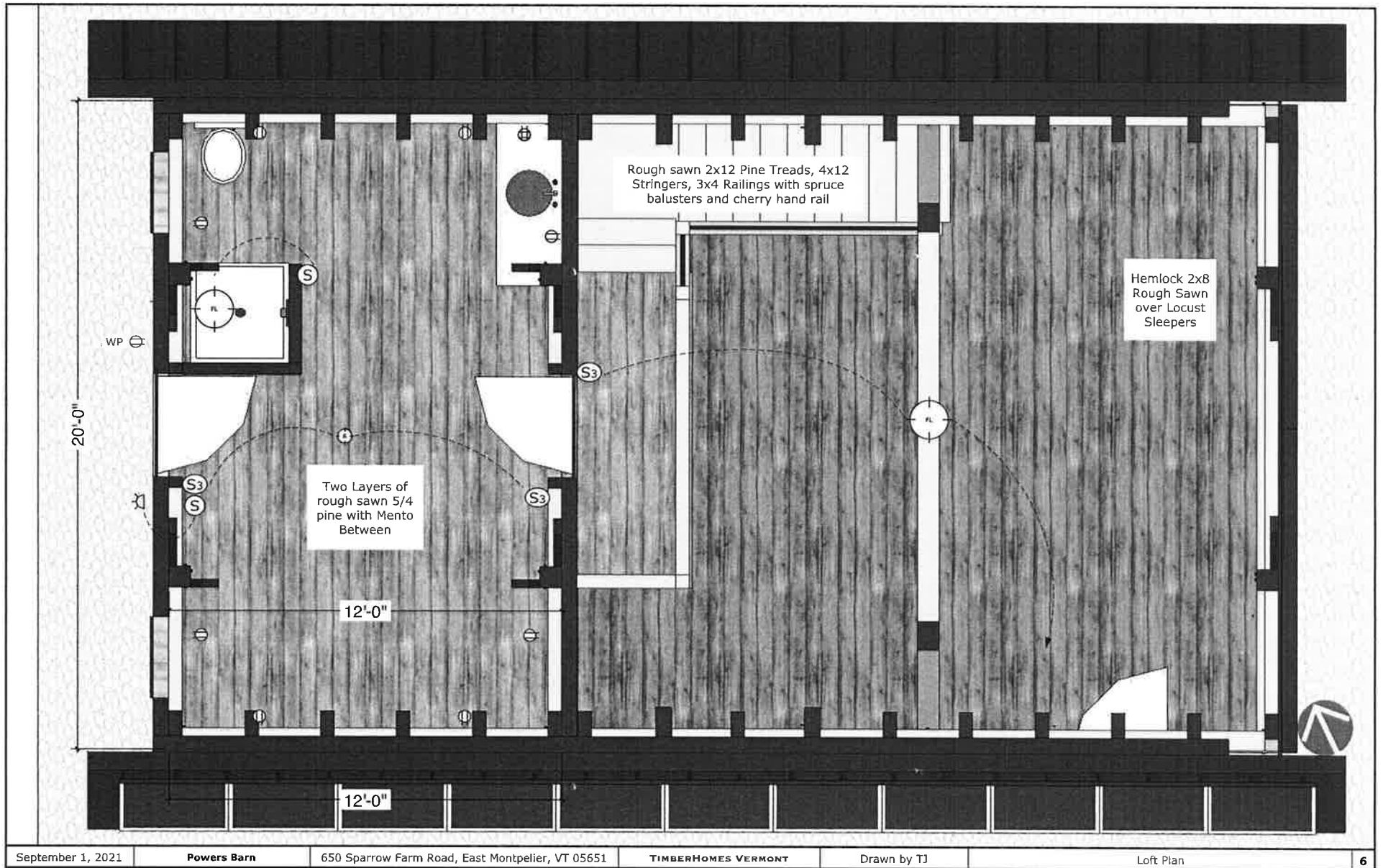












### General Timber Frame Notes:

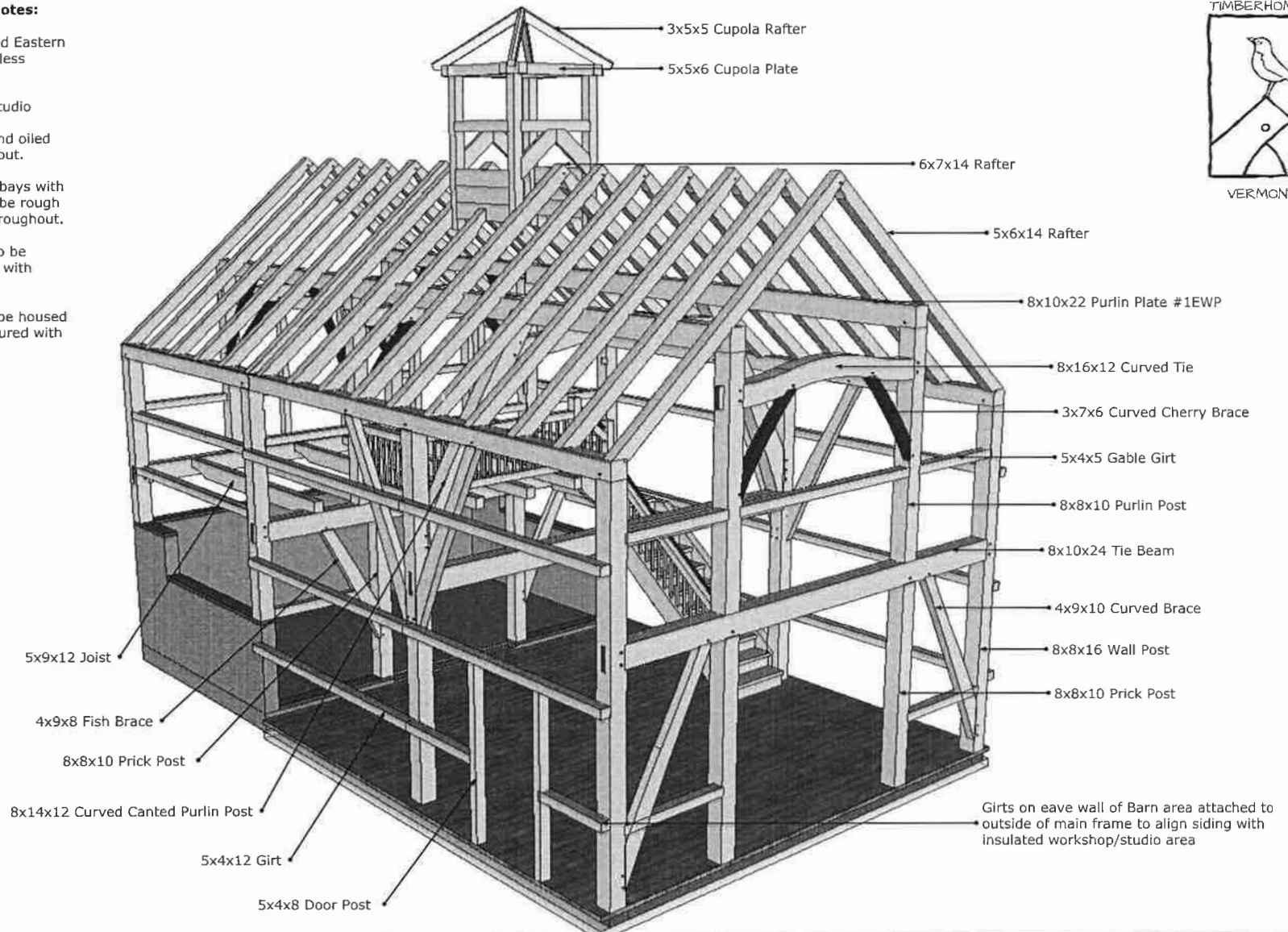
All Timber to be unseasoned Eastern White Pine #2 or Better unless otherwise noted.

Timbers in the workshop/studio portion (bay with concrete foundation) to be planed and oiled with 1/8" chamfer throughout.

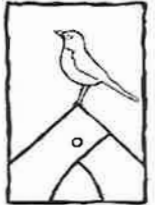
Timbers in Barn area (two bays with wood floor on sleepers) to be rough sawn with 1/8" chamfer throughout.

All principal timber joints to be mortise and tenon secured with octagonal pegs.

Girts, joists and rafters to be housed where appropriate and secured with structural screws.

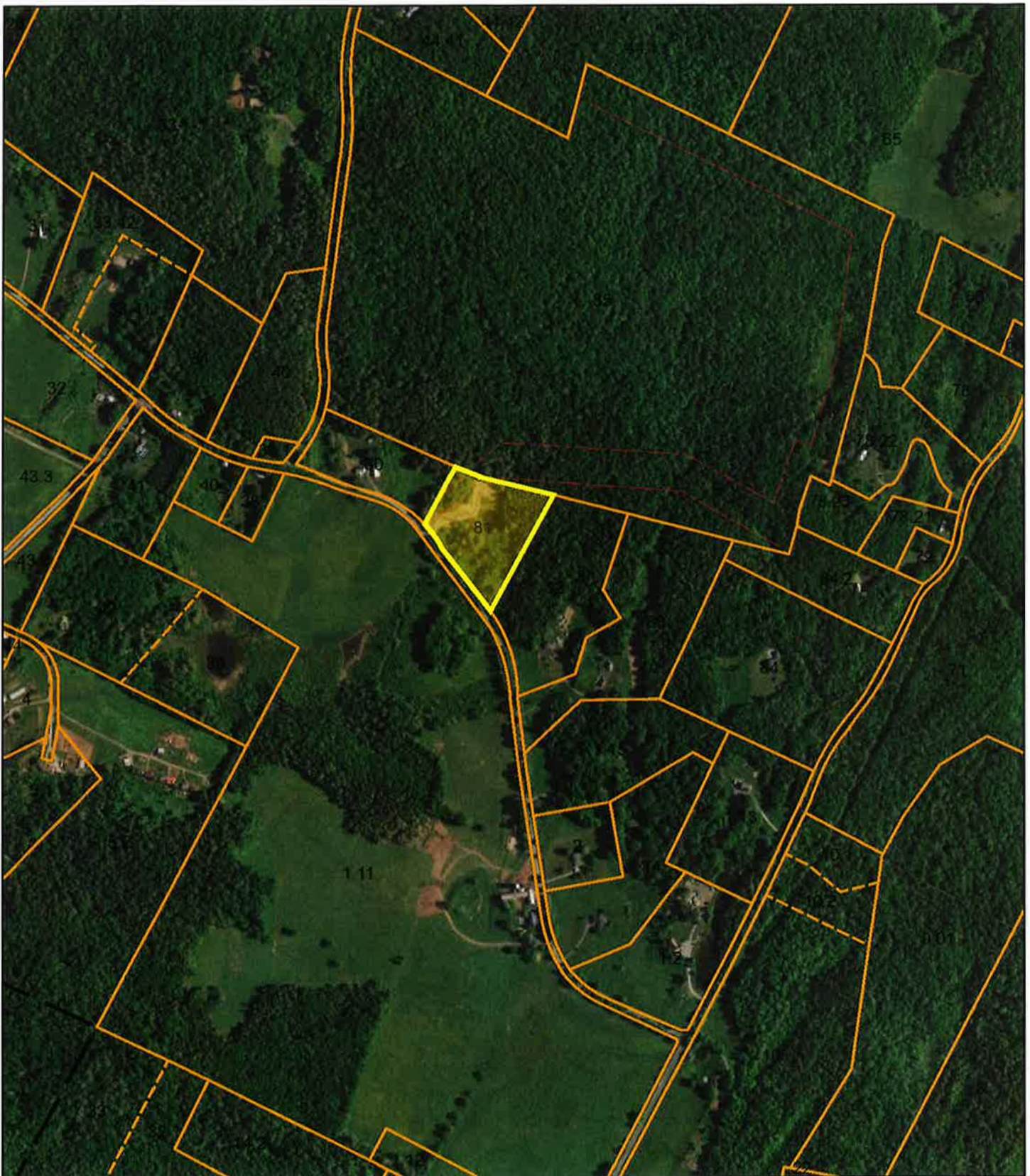
