Describe work to be performed Construction of a timber-frame solar canopy in a field approximately 120 to 140 feet due North of existing house in a field. Project includes land leveling the solar canopy site, installing metal ground screw footings, and a timber frame structure that sits atop footings. Solar site, installing will be installed on top of the timber frame structure. This project includes the excavation of a 18" - 24" trench for buried conduit installation from the solar canopy back to the house. Trench is approximately 150ft and will be backfilled and topped with seed and straw. Point of interconnection to the electrical grid is planned to be a backfeed breaker in the backup gateway for the to be installed Tesla Powewall batteries.

1. "Participation" in a DRB proceeding shall consist of offering, through oral or written testimony, evidence of a statement of concern related to the subject of the proceeding.
2. The notice of appeal shall be filed by certified mailing, with fees, to the Environmental Division of the Vermont Superior Court and by mailing a copy to the East Montpelier Zoning Administrator, who shall supply a list of interested persons (including the applicant if not the appellant), to the appellant within five (5) working days. Upon receipt of the list of interested persons, the appellant shall, by certified mail, provide a copy of the notice of appeal to every interested person. If any one or more of those persons are not then parties to the appeal, upon motion they shall be granted leave by the court to intervene.
