My background is in green real estate and sustainable development. I am a serial entrepreneur and committed to working with fellow committee members to address key issues, foster community engagement and help our community thrive within planetary limits. I have a daughter at St. Andrews in Scotland and a son at Brown in Providence. They have both given me marching orders to help make our community enticing for young people so they may move back here and convince their friends to join them as well.

Name of applicant: Glenn Weyant

I am currently on the DRB and this has given me an opportunity to begin learning about the issues concerning planning and development in East Montpelier.

From the mid-80s thorough early 2000s I worked as a journalist covering planning boards and development in New York State, Massachusetts and Arizona.

Those experiences led to a life-long interest in land use issues and how communities wrestled with preserving a towns character, land and open spaces, while also creating housing and business opportunities. From what I can tell, East Montpelier (and Vermont in general) appears to be at a crossroads where the population is aging, drastic weather events are more common, housing stock is limited, high prices are making it difficult for many to become homeowners and property owners are feeling the squeeze from increased taxes.

My partner (Matthew) and I moved to Vermont last June from Oklahoma. He is an environmental engineer and I am a social worker. We bought our home in East Montpelier as first time buyers. We live just outside the downtown area of the North Montpelier Historic District and have loved being a part of the "Singing Bridge" community for the past 8 months. We have many animal companions and hope to work the land we purchased into a homestead with time. We are both college educated. I completed my Master's program shortly after moving here. I have previously served on the Tree Board for the City of Norman, Oklahoma as part of the city's green initiative and to stay compliant with the Arbor Day Foundation's Tree City USA initiative. This board was an advisory board and did not have regulatory authorities within the city.
